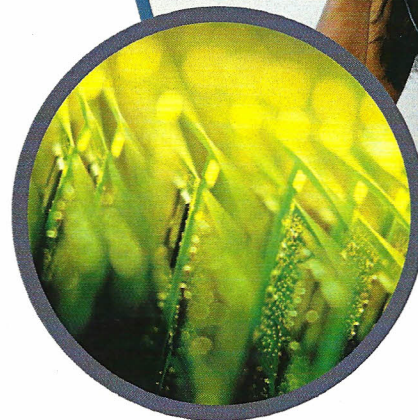
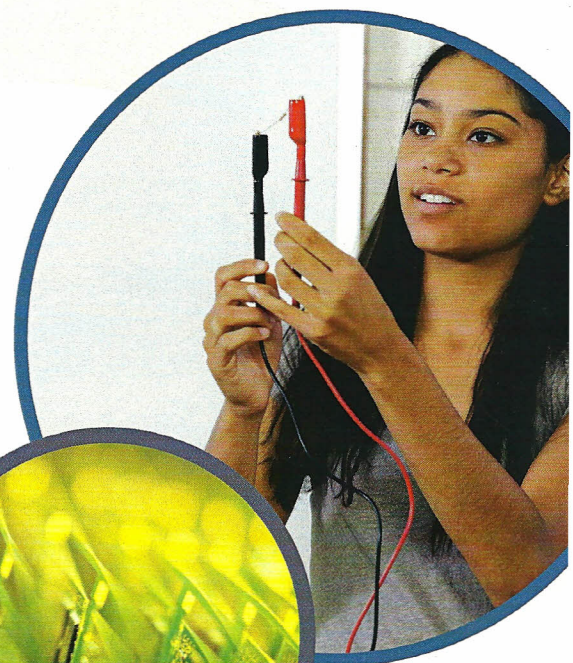

Expanding and Improving Career-Technical Education in Ohio

CAREER-TECHNICAL EDUCATION EXPANSION OPPORTUNITIES WORKSHOP

Presenter: Mike Cowles, Assistant Director

This session will explore various ways to expand career-technical education offerings. Topics include middle grade program implementation, including the application and submission process for approval and expansion of career-tech education into the ninth and 10th grades. Opportunities to use career-tech student organizations, dual enrollment and College Credit Plus as incentives to drive participation in career-technical education will be explored.

INDUSTRY CREDENTIALS AND WORKKEYS REIMBURSEMENT

Presenter: Kimberly Wolfe, PhD, Assistant Director, (Business, Technology and Arts)

House Bill 64 provides the opportunity for city, local and exempted village school districts, community schools, stem schools and joint vocational school districts to receive reimbursement for the students who acquire industry-recognized credentials or journeyman certification. Additionally, it allows schools to be reimbursed for WorkKeys assessments administered to students who meet specific criteria. During this workshop, information will be shared regarding the industry credentials and WorkKeys reimbursement processes as outlined by the Ohio Department of Education's Office of Career-Technical Education.

CAREER-TECHNICAL EDUCATION PROGRAM REVIEW

Presenter: Leah Amstutz, Associate Director, (Career Paths and School Improvement)

The intent of the Career-Technical Education Program Review is to maximize the use of resources that will improve the quality of career-technical education programs. The Career-Technical Education Program Review is a four- to five-year process. The district will conduct a self-review in the first two years. In the third year, a district will implement identified improvement strategies with the assistance of the Career-Technical Planning District and the Ohio Department of Education. The fourth and fifth years will be used for additional onsite reviews by the Ohio Department of Education in collaboration with the Career-Technical Planning District if a career-technical education program is still not in compliance with the targets established for the performance indicators. Learn firsthand how the monitoring system will work through the SAFE account, including a review of the performance indicator data benchmarks, utilization of the quality program standards and guidelines on the program review.

REPORT CARD

The 2016 career-tech education report card will include new measures, as well as grades for industry credentials and components. This session will outline each of these changes, as well as answer all accountability-related questions.
